\* On 18 March 2022, Boss announced it had successfully completed a bookbuild to raise \$120 million through a two-tranche placement (**Placement**) and would be undertaking a Share Purchase Plan (**SPP**) to raise an additional \$5 million. Tranche 1 of the Placement settled on 23 March 2022 and raised approximately \$92.07 million (before costs), which is included in Section 5 above.

Post quarter end, the SPP closed on 4 April 2022 raising \$5 million (before costs), which was received on 12 April 2022. Tranche 2 of the Placement, to raise an additional \$27.93 million (before costs), is subject to shareholder approval to be sought at a General Meeting to be held on 29 April 2022. Therefore, funds received under the SPP and Tranche 2 of the Placement are not included in Section 5 above.

In addition to the unrestricted cash noted in Section 5 above, the Company also holds a 100% cash backed environmental bond of \$8.92 million, which the Company treats as restricted cash.
